#### Programs:

##### 1. Human Rights and Legislation

This program provides information and counseling to vulnerable groups regarding their human rights and relevant legislation.

##### 2. Education

This sectoral program is focused on developing educational programs that meet the needs of children, youth, and adults.

##### 3. Healthcare

The program has two main approaches:

A) Promotion of preventive activities such as medical education for families and the community, covering hygiene, identification of infectious diseases, and regular medical and dental missions.

B) Treatment activities focused on providing medical assistance (equipment), referring patients to hospitals, covering their expenses if they are unable to do so, and other assistance from our side whenever we are able to help.

##### 4. Employment

Ensuring equal opportunities for constitutional rights, i.e., equal representation of all nationalities in governmental political positions and employment.

##### 5. Fundraising (Income Generation)

This will enable people to engage in fundraising activities that increase their income level to meet their basic needs such as food, clothing, shelter, and other necessities.
